on how to operate the bookings software, communicate with clients and get a good understanding of how to manage and run a dog grooming business. If there are any appropriate courses the candidate can be sent on then that will also be taken into consideration.

Formal training includes: An iPET Network certificate in: Canine behaviour; canine skin, hair and nail health; and canine first aid. Courses are dependent on the official course dates and availability.

Informal training includes: Practical training in dog grooming and handling, while being mentored and guided by one of our professional groomers.
