Assist O&M Technicians with the water/wastewater treatment plant preventative and corrective maintenance planning and execution, and reporting of same, including scheduling specialist trades as required.

Procurement of site / lab consumables/spares within contract budgets.

Planning, execution and reporting internal and external water/wastewater treatment plant site process audits.

Training of O&M Technicians on all process activities.

Process fault finding including laboratory work, jar testing and reporting.

Monitoring of external laboratory reports, particularly in relation to exceedances and reporting of same.

Assisting with the Process Proving stage of commissioning.

Assisting with the implementation of HSQE/Process/Energy site audits.

Develop and maintain Standard Operating Plant Procedures (SOPPs) where required.
